Dear Mike,

Obviously no need to apologize, since the beginning of the GRSF we said that it would have helped also to improve our source databases, from data modelling to content. In example FishSource has modified its model and added services accordingly, in FIRMS we also upgraded the data model (e.g. we have introduced the notion of assessment unit vs true stock) and we have spotted some wrong metadata and imprecise reports which we are regularly fixing as they are encountered.

This being said, unless specific needs, the GRSF should not alter the source content if not for improving it, in example with mapping to standards. FYI, a related issue on accented words was solved last week https://support.d4science.org/issues/12421 and all concerned records will be update with such fix in the coming days.

In conclusion, thanks for your clearance, in a separate thread I am going to ask for approving this set of RAM records.

Just a note that spelling & capitalization errors that we previously had in RAM 4.35 have been resolved. Working with the recently-submitted version 4.48 will avoid some of these earlier issues.

Many of the 'stocklong' names in RAM have been corrected or changed for regional consistency, but the 'stockid' names have generally remained unchanged, so those can be used for linking with previous versions.
